



Sir/ Madam,

I am directed to inform that assessment of the physical and the other teaching facilities available for continuance of recognition of MBBS degree granted by Amrita Vishwa Vidyapeetham (Deemed University) in respect of students being trained at Amrita Institute of Medical Sciences, Kochi was carried out by the Council Assessors on 9th & 10th July, 2012. The said assessment report was considered by the Board of Governors at its meeting held on 22.10.2012. The decision of the Board of Governors was communicated to you vide letter dated 09.11.2012, 24.12.2012 & 15.02.2013 with the request to submit the compliance after rectification of deficiencies as indicated as the assessment report for further necessary action in the matter.

In reference to the council letter dated 09.11.2012, 24.12.2012 & 15.02.2013 the compliance has been received on 16.05.2013. The assessment report (9th & 10th July, 2012) alongwith the compliance under reference has been considered by the Board of Governors at its meeting held on 6th & 7th August, 2013. The Board of Governors decided that the recognition of MBBS degree granted by Amrita Vishwa Vidyapeetham (Deemed University) in respect of students being trained at Amrita Institute of Medical Sciences, Kochi be continued restricting the number of admissions to 100 (One hundred) students per year.

It is further to inform you that your institution is fully responsible to fulfill and maintain norms including the infrastructure both physical and human resource, teaching faculty and clinical material etc. throughout, as stipulated in Regulation of Medical Council of India. In case false/wrong declaration or fabricated documents have been used for procuring the approval of Continuation of recognition by the Board of Governors and the said
