"The Postgraduate Committee considered the assessment report (June, 2013) and decided to recommend that MD(Geriatrics) qualification for 1(One) seat granted by Amrita Vishwa Vidyapsetham University in respect of students being trained at Amrita School of Medicine, AIMS, Kochi be recognized and included in the 1st Schedule to the LM.C. Act, 1956.

- (5) The procedure for Renewal of recognition shall be same as applicable for the Award of recognition.
 - (6) Failure to seek timely renewal of recognition as required in sub-clause-4 shall invariably result in stoppage of admissions to the concerned Post Graduate course....."
