Course Description:

This course aims at exploring the materiality of the female body and its foundational explanatory role through the detailed study of intersectional culturalism in young adult novels. It will also be an introduction to the specialised field of fat studies which started emerging during the 1960s and ever since then, it has studied and analysed the ways fat people are oppressed, the reasons why, who benefits from that oppression and how to liberate fat people from oppression. Fat studies conceptualize this paradigmatic resistance to the tangible or visible form of identity tied to the body. The objectification theory and critical fat studies provide a theoretical framework that aids in constructing and guiding students to navigate the complex theoretical maze of Feminist Fat studies.
