INTRODUCING AIMS

India is the most populous nation on earth. This means that India's health problems are the world's health problems. And by the numbers, these problems are staggering 71 million cases of diabetes, nearly half the world's blind population, and 60% of the world's incidences of heart disease. But behind the numbers are human beings and we believe that every human being has a right to high-quality healthcare.

INTRODUCTION

EXECUTIVE MASTERS IN PUBLIC HEALTH at Amrita Institute of Medical Sciences and Research Centre, Cochin, Kerala, India is designed to meet the healthcare needs of people. This is an innovative course of Amrita Vishwa Vidyapeetham, and we are committed to make this course of global standard. It is a 24-month course and has been designed to build an understanding, knowledge, skills and attitude for better public health practice and research. The standards and syllabus are at par with the renowned international and national universities.

All students receive a comprehensive training and skill building in the six core suites-

- 1). Epidemiology
- 2). Biostatistics
- 3). Gender, Nutrition and Population Sciences
- 4). Environmental health & Occupational health
- 5). Social and behavioral sciences

6) . Health care and system management, Ethics in Public Health and Research, Health Economics and Policy.

In addition to the above mentioned core suites, the students will have to do an additional elective. Different options for electives will be provided during the two-year course. It will be available in the pattern of workshops, CMEs on topics of public health importance such as health economics, epidemiology etc. The candidate can select any one topic of interest.

In all classes which are mandatory, the emphasis is on the relevance of information and skills to public health practice.

The objectives of the Executive Masters in Public Health programme are:

- To equip students to have an overall perspective on public health.
- To create good program managers in public health.
- To inculcate interdisciplinary approach to problem solving skills in public health.
- To encourage interdisciplinary research in public health.
- To improve leadership skills in public health. To prepare students to tackle current and emerging global public health problems such as pandemic flu, AIDS, bioterrorism, obesity, diabetes, disparities in access to healthcare, and many other critical public health problems.
- Recognizes that in today's world, a thorough and rigorous public health education must embrace multiple areas including biostatistics, environmental health, epidemiology, health services administration, social and behavioural sciences, biological sciences, ethics, the role of information technology in health, health policy and law in health.
- The program requires a field experience that serves as a capstone experience and helps students integrate knowledge across courses.
- To equip participants to gain public health expertise in their corresponding specialties and to establish leadership in research.

ELIGIBILITY FOR ADMISSION

a) Indian Students

Graduates with minimum qualification of MBBS/BDS/ AYUSH/ B.Sc. Nursing/B. Pharm, Pharm D, BVSc or any Master Degree in Government or Private Health sector regularly employed in a Government/Private Sector (work experience of minimum 2 years).

b) Sponsored Students

(Government of Kerala, Govt. of India & Non – Government Organizations)

Ten seats will be earmarked for all the above categories.

c) Age:

There is no age limit and for government sponsored candidates it will be as per government norms.

d) Selection Procedure

Total intake of maximum 30 students per year.

SELECTION CRITERIA FOR ADMISSION

- Eligible candidates will be invited for an online personal interview
- Selection will be made on the basis of academic scores and performance in the interview

SELECTION AND COUNSELLING

PROXY REPORTING FOR ADMISSION

Reporting for admission by proxy is not permitted. Admission of the allotted candidates who do not report to the Admission Office, Amrita School of Medicine, Kochi shall stand cancelled.

In extremely exceptional cases, where the candidate is unable to report physically due to illness for attending admission procedure, Chairman – Admissions at his sole discretion may permit candidate's father, mother to attend counselling on behalf of the candidate on the basis of a written request. Also specific authorization from the candidate with relevant Medical Certificate from a Medical Officer not below the rank of a Civil Surgeon or a Clinical Associate Professor of a Medical College should be submitted at the time of reporting for admission.

VERIFICATION OF DOCUMENTS

- All admissions/allotments are subject to verification of the original certificates and documents submitted by the candidates. The decision of the Manager - Admissions regarding the eligibility of applicants shall be final.
- If at any time before or after admission it is found that the candidate does not meet the eligibility requirement, seat will be denied to him/her. Therefore, it is the sole responsibility of the candidates to ensure that he/she meets all the eligibility requirements.
- At the time of reporting for Admission to Amrita Institute of Medical Sciences, Kochi, candidates should be accompanied either by their parent or spouse and should produce the following documents / certificates in Original along with one set of photocopies.
- A document to prove the Date of Birth (SSLC or Birth Certificate)
- Plus-Two Mark List
- Degree Certificate with mark list
- PG certificate with mark list
- Transfer Certificate & Character and Conduct Certificate from the Head of the

Institution last studied

- Migration certificate from the University from where the candidate secured the last degree
- Relieving letter / NOC from the previous employer, whichever is applicable
- Two copies of Aadhar Card and PAN Card of the candidate
- Recent passport size close-up color photographs of face - 6 no's
- Physically Handicapped Certificate (if applicable)
- Caste Certificate (if applicable)
- Work Experience Certificate
- Medical Certificate for physical fitness and mental soundness from a medical officer (Government Hospital / Government Medical College) not below the rank of Civil Surgeon or a Clinical Associate Professor.

NOTE:

1)The above certificates in originals are mandatory.

2) Candidates coming for admissions / counselling with incomplete list of the above documents will not be allowed to attend the admission procedure and will be rejected.

All the certificates submitted are subjected to scrutiny. In case of any fake/bogus/false information, the admission office will initiate the same to the concerned department to cancel the enrollment process. During this course of action, if the college suffers any damages/ loss of reputation due to vacancy, Amrita reserves the right to claim liquidated damages from the candidate.

ANNUAL FEES

Annual Tuition Fees (Scholarship) – Rs. 1,50,000

- Candidates must remit the Course Fees (Tuition Fees) before the time of reporting through the Amrita Online Admission Portal.
- Admission Processing Charges of Rs. 2,500 is non-refundable. Candidate should pay Admission Processing Charges of Rs. 2,500 as Demand Draft drawn in favour of “Amrita Vishwa Vidyapeetham, Kochi”.
- Candidates are required to submit the original hardcopy of the Demand Draft while reporting for document verification.

In addition to this, residents should pay the Tuition Fees for the remaining course duration (as applicable to each course) as liquidated damages to the institution.

Category	Percentage of Refund of fees	Point of time when notice of withdrawal of admission is received in the HEI

(4)	50%	30 days or less, but more than 15 days after formally notified last date of admission
(5)	0%	More than 30 days after formally notified last date of admission
